Reports

State Aid Report

Assistant Superintendent of Finance Mike Cuneo updated the Board of Education on the current funding outlook for public schools in Michigan. Districts received a \$175 per-student reduction in state aid in the 2019-20 school year and will receive an additional \$350 per student for the 2020-21 school year through the federal CARES Act. Much of those funds will be used to purchase PPE and cover other expenses related to the pandemic.

Dr. Shibler and Mr. Cuneo are working with our state legislators to help them understand the challenges created by the COVID pandemic and how they can support districts. We will have a better idea about state funding for 2020-21 following the State Revenue Estimating Conference on August 24 and when the State releases their budget by the end of September.

New Business

RPS Return to Learn Plan (RPS COVID-19 Preparedness and Response Plan)

Following more than two months of extensive planning by RPS administrators and teachers, the RPS reentry plan for the 2020-21 school year has been finalized. Assistant Superintendent of Instruction Mike Ramm presented to the Board of Education the Rockford Return to Learn Plan along with a summary of our plan to accompany the detailed document. Mr. Ramm is holding a Rockford Virtual livestream tomorrow at 2:00 p.m. Parents enrolling students in face-to-face instruction will receive information over the coming days regarding details about the start of school, including device pick-ups.

Upon recommendation of Dr. Shibler, motion was made by Lisa Kreager, supported by Geoff Downs, to approve the re-entry plan as presented, offering parents two options (face-to-face instruction or Rockford Virtual), and that teachers deliver instruction remotely to students enrolled in face-to-face instruction via livestream from their classrooms from August 24 through September 11, as presented. Trustee Reichenbach acknowledged that the district is going above and beyond what is recommended through the Governor's MI Safe Schools Roadmap. President Postema commended Dr. Shibler and his administration for meeting this challenge. Motion carried unanimously. Both documents will be sent to all staff and families and posted on the district website tomorrow.
