## Meadow Ridge Elementary Parent Involvement Policy

### **School Parent Involvement Policy Purpose Section 1118 (b)**

The purpose of the Meadow Ridge Elementary Title I parent involvement policy is to jointly develop with parents and distribute to parents of participating children a Parent Involvement Policy that the school and participating children agree on. Meadow Ridge encourages parent involvement through programs designed to increase parent school communications. Parents will partner with us by providing input and evaluating Title I programming. Parents will help design and participate in a joint school and parent compact which will be reviewed at conferences. Parents will be an integral part of our school improvement teams that meet monthly throughout the year. Parents are always welcome to volunteer in classrooms and offer suggestions for enriching the academic environment for their children. Parents of Meadow Ridge Elementary will be informed of this parent involvement policy in an understandable format and in language parents can understand.

Meadow Ridge will:

- Create a team of staff and Title I parents to create, review, evaluate, and provide input into Title I Parent Involvement Policy.
- Develop the Meadow Ridge Parent Involvement Plan in a collaborative effort between parents and staff.
- Share the Parent Involvement Policy with parent groups such as the PTO and with staff at staff meetings.

### **Policy Involvement Section 1118 (c)**

#### **Section 1118 (c) (1) Convene an Annual Meeting**

Meadow Ridge will:

- Hold an annual Targeted Title I parent meeting each fall to explain Title I programming and how parents can be involved.
- Parents will be invited through multiple methods including paper invitations, school web site announcements, emails, school newsletters and personal contact as needed.

#### **Section 1118 (c) (2) Offer flexible meeting times and varied activities to support and encourage parent involvement of all parents**

Meadow Ridge will:

- Offer alternatives for meeting times including evening meetings, before school meetings or personal meetings with Title I staff.
- Share related Targeted Title I information and encourage parent involvement at curriculum nights the week before school starts, at our fall Title I parent night (child care provided) parent teacher conferences twice a year, Title I parent nights (child care provided) and Title I planning meetings with the building School Improvement Team.

#### **Section 1118 (c) (3) Involve parents in planning, reviewing, and improving the Targeted Title I program**

Meadow Ridge will:

- Provide time for the Title I parents and staff to meet, review and revise the Parent Involvement Policy and Plan at flexible times.
- Review the Parent Involvement Policy and Plan at school improvement meetings.
- Provide the opportunity for parents to give input and make suggestions for improvement on the annual Title I Parent Survey sent home each spring.

- Hold an annual Targeted Title I parent meeting each fall to explain Title I programming and how parents can provide input into the Parent Involvement Policy and Plan.
- Discuss School and Home Parent Compacts at conferences twice a year.
- Post the Parent Involvement Policy during conferences and on the Meadow Ridge website.
- Share Title I communications in the Meadow Ridge newsletter.
- Host Title I parent nights to share ideas and inform parents of the Title I programming.

**Section 1118 (c) (4) (a) and (b) Provide timely information about the Targeted Title I program, the academic curriculum, , assessments to measure progress, and proficiency levels of students**

Meadow Ridge will:

- Notify parents if their child enters into Title I with a letter of notification as well as a personal phone call by the child's classroom teacher.
- Upon entering Title I, provide parents a booklet to keep at home that share ideas for them to use at home to compliment the Title I programming at school.
- Hold an annual Targeted Title I parent meeting each fall to explain Title I programming and how parents can be involved.
- Update parents on their child's progress in the Title I program every six weeks through a written progress report.
- Provide additional progress updates through Title I communications including emails, personal phone calls, written reports at conferences, and newsletters.
- Share curriculum updates at Curriculum night the week before school starts, conferences twice a year, through classroom and building newsletters, and on the district website.
- Provide proficiency levels on report cards three times a year and progress reports for Title I students every six weeks.
- Share state expectations for proficiency through parent MSTEP reports, Common Core standards on the district website, and district curriculum maps.

**Section 1118 (c) (4) (c) Provide parents the opportunity to formulate suggestions and to participate in decisions relating to the education of their children**

Meadow Ridge will:

- Discuss Title I programming at conferences twice a year.
- Provide parent input surveys at all Title I parent nights to allow for suggestions and input.
- Encourage parents to contact Title I staff, classroom teachers, and/or the building principal to discuss any decisions related to the education of their child.
- Respond in a timely manner to keep parents informed.
- Hold an annual Targeted Title I parent meeting each fall to explain Title I programming and how parents can provide suggestions to the program.
- Have Title I programming on the PTO agendas to allow parents attending an opportunity for feedback.
- Send out an annual Title I survey each spring to all parents and act on their suggestions for the next school year's programming.

**Section 1118 (c) (5) Ensure that if the Targeted Title I program plan is not satisfactory to the parents of participating parents, submit any parent comments on the plan when the school makes the plan available to the LEA**

Meadow Ridge will:

- Inform parents that this is a flexible document and their input is welcome.
- Share the plan at the fall Title I parent night and provide time for feedback. Parents can submit feedback that will be recorded by Title I staff and submitted to the Director of Title I to consider for changes.
- Provide a section of the spring Title I parent survey for any areas they may not be satisfied with as well as a place to offer suggestions for change.

Meadow Ridge will:

- Provide Title I parents time to review and provide input into the creating of the compact annually along with school staff members.
- Provide all parents a copy of the compact upon entry into the Title I program.

- Provide a six-week progress update after each RtI Collaborative Action Team meeting
- Communicate with parents through newsletters, emails, and personal phone calls

### **Section 1118 (d) (2) (c) Afford parents reasonable access to staff and provide opportunities to volunteer, participate, and observe in their child's class**

Meadow Ridge will provide reasonable access to staff through:

- Email communications
- Newsletters
- Voicemail
- Notes
- School website and social media
- Parent conferences twice a year
- Title I parent nights

Meadow Ridge will have the following opportunities to volunteer in their child's class and education:

## **Building Capacity for Parent Involvement 1118 (e)**

- Share take-home materials for Title I students to use with their families at home such as take home reading books
