Reports

Student Representative

Student representative Guin Waite reported to the Board of Education on several initiatives, including Winter Wishes and daily Halloween-related activities sponsored by the Student Council this week, including drive-through trick-or treating at the high school on Thursday, October 29 from 5-7PM. Guin reported that senior students very much appreciated attending last week's football game. Guin stated today's re-entry to school after the two-week remote learning period was very positive and students and staff appreciated returning to the building.

Old Business

Extended COVID-19 Learning Plan Reconfirmation Hearing

In compliance with Public Act 149, the Board of Education approved the Rockford Public Schools Extended COVID-19 Learning Plan in September. The Act requires that the Board of Education reconfirm the district's Extended CLP every 30 days, therefore, Superintendent Shibler will present this for Board consideration on a monthly basis.

As part of the reconfirmation process, Assistant Superintendent of Instruction Mike Ramm reported to the Board of Education on the district's delivery of instruction options under the Plan, whether or not the district is offering higher levels of in-person instruction for special populations, and weekly attendance rates which include logged interaction time between teachers and students. Mr. Ramm reported on trimester transfers between F2F and Rockford Virtual and stated that two-way mental health screening will be completed in two weeks.

President Postema welcomed comments from the public regarding the instructional delivery method. Because Ms. Russo's comments listed under the Call of the Audience pertained to this matter, they will be included in the Reconfirmation Meeting Summary.

The Board of Education commended the district for providing flexibility for families and for exceeding state requirements relative to delivery of instruction. Dr. Shibler stated the district is acting upon the advice of legal counsel to follow operational directives issued by the MDHHS.

Upon recommendation of Superintendent Shibler, motion was made by Lisa Kreager, supported by Laura Featherston, approving the October 2020 Reconfirmation Plan. Motion carried unanimously. All approved Reconfirmation Meeting Summaries will be made available on the district website <u>transparency reporting page</u> under the Extended COVID-19 Learning Plan section.

New Business

Resolution Regarding the Open Meetings Act

Assistant Superintendent of Human Resources Korie Wilson-Crawford reviewed with the Board of Education a resolution relative to the Open Meetings Act and virtual meetings. The Open Meetings Act was recently amended to grant greater latitude with respect to electronic participation by members of the Board of Education and the public in certain circumstances, and the resolution outlines the Board's desires to utilize electronic participation in compliance with the law. Upon recommendation of Superintendent Shibler, motion was made by Nick Reichenbach, supported by Lisa Kreager, adopting the Resolution Regarding the Open Meetings Act as presented. Roll call vote was taken. Ayes: 7. Nays: 0. Motion carried unanimously.
