## Student Representative

Student representative Guin Waite was unable to attend this evening's meeting.

#### Collaborative Team Reports

The Board of Education receives information about events occurring in our schools in the form of monthly collaborative team reports.

<u>Elementary</u>: Roguewood Elementary Principal Teya Cotter reported on school pictures, preparations for summer learning, CAT and BCT meetings, several reading and giving initiatives, DARE programming, the upcoming testing window, and interventions and supports being provided to students. Third and fifth grade teams have won Odyssey of the Mind state championships and are moving on to world competition.

<u>Secondary</u>: North Rockford Middle School Assistant Principal Al Reickard reported on the upcoming testing window requiring adjusted student schedules to allow for distancing, spring sports, upcoming parent-teacher conferences, PLC work, zero hour and expanded co-op opportunities at River Valley Academy, and COVID monitoring as the high school determines the status of year-end activities.

<u>Rockford Virtual</u>: Principal Dr. Kelley Amshey reported on year-end testing challenges for virtual students which must be administered in person, efforts to ensure students complete the school year, and a School News Network article about a Rockford student's credit recovery through the RV Program.

#### Bid Recommendation - Middle School Finish Upgrades (2019 Bond Issue)

Assistant Superintendent of Finance Mike Cuneo presented to the Board of Education bids for finish upgrades at East Rockford Middle and North Rockford Middle schools. The Board of Education reviewed the bid summary in an earlier study session. Upon recommendation of Mike Cuneo on behalf of Dr. Shibler, motion was made by Geoff Downs, supported by Nick Reichenbach, to authorize Owen-Ames-Kimball Co. to issue Letters of intent, in the amounts indicated, to contractors and suppliers listed below, pending confirmation that all requirements of the Contract Documents are met and that, furthermore, upon receipt by Owen-Ames-Kimball Co. of the appropriate documentation, contracts be awarded to these contractors and suppliers by Rockford Public Schools. The project will be funded through the 2019 bond issue. Motion carried unanimously.

## Bid Recommendation – East Rockford Middle School Flooring Project (2019 Bond Issue)

Assistant Superintendent of Finance Mike Cuneo presented bids received for a flooring project at East Rockford Middle School. The Board reviewed this in an earlier study session. Upon recommendation of Mike Cuneo on behalf of Dr. Shibler, motion was made by Timothy Lewis, supported by Jake Himmelspach, to award the bid to Tarkett in the total amount of \$443,745.96 as presented. The project will be funded through the 2019 bond issue. Motion carried unanimously.
